
## Dear Friends of St. Mary's

We are writing to you to ask for your support to help safeguard the future of our Church, not only as a place of worship, but also as a significant historic building which we are sure you recognise as a valuable asset to the village of Preston on Stour, and indeed the County of Warwickshire.

St. Mary's, a Grade 1 listed building, was chosen as one of Simon Jenkins' "England's Thousand Best Churches" and is listed by Nickolaus Pevsner in his architectural guides. Whilst extensively remodelled during 1750-56, its origins date back to Anglo-Saxon times with the village name of Preston being a derivation of "Priest Town". St Mary's and its churchyards have always offered the entire community a place of beauty for



quiet reflection, baptisms, weddings and funerals, of course regular services and our ever popular nativity play. The operational bell tower in itself is unusual, not only because the Bells continue to ring out, but also because there are few surviving churches with a 3 bell tower.

As you can imagine, being so old, St. Mary's requires continual maintenance and over the last few year we have repaired the external stonework and completely renovated the east window. At the end of January 2019 we will undertake the first repainting of the interior walls for many years, a job which will come at a cost of approximately £12000. This money has to come from the Church funds where the only income is service related collections and donations from parishioners and supporters.

Over the years we have been very fortunate to receive support in the form of one-off donations and legacies from benefactors as well as some other activities to contribute to the annual running costs and regular maintenance program.

However we are keen to encourage other organisations or individuals to help us in the future. As mentioned above, we are facing a significant expense to protect the church and maintain it as the central feature of the village for both our own and future generations.

To be blunt, the cash reserves accumulated over many years are rapidly dwindling!

We are hoping that you would consider making a donation to the St. Mary's Fabric Fund. All money raised will be ring-fenced and go directly to the maintenance of St Mary's and not be mixed with the funds required for the general running of the church. The Gift Aid process helps make donations tax effective and hence increase the value of your contributions.

Thank you in advance for any support you might be able to offer and we would also like to thank all who have, and continue to contribute their time and energy to the upkeep of our beautiful church.
